I understand and agree that if my child wishes to drop out of class(es) at any time that I must notify Gotta Dance, LLC either in writing or by phone by the last day of the month prior to drop out, or I am responsible for the next month’s tuition. 6. I understand that costume fees, recital ticket fees, picture fees, etc. are in addition to normal monthly tuition. 7. I understand and agree that I will pay a fee of \$30 for a NSF/returned check. If this occurs twice, I will no longer be permitted to pay by personal check. 8. These classes may or may not be re-scheduled due to their discretion and the monthly fee will remain the same. 9.
